



## **Country Idol Karaoke Promotion Rules and Regulations**

**Every fourth Thursday of each month, January 28 - June 24**

**Grand Prize: One (1) winner will have the chance to perform a 5-song mini concert.**

*Participants must be 21 years or older and have valid photo ID.*

### **Entries**

On the fourth Thursday of every month, Country Idol Karaoke contestants must register with a Vapor or WGNA representative between 7 and 9pm. Singers will be randomly picked for their chance to impress the judges between 9-11pm.

### **Contest**

The top 3 singers of the night will be invited back for Country Idol Karaoke Finals on June 24, 2010. Weekly finalists will receive a t-shirt or similar prize.

The winner of the finals will receive a flat screen TV and will have the opportunity to open up Country Night at Vapor with a 5-song mini concert of their own. Date of performance is left to the discretion of Vapor management.

Winners are determined by judge's decision. Judges' decisions are final. Judges of qualifying rounds are representative of Vapor Night Club. Guest judges (TBD) will be brought in for Country Karaoke Finals on June 24.
