Rules and Regulations**

Every "Hot Country Dance Party" Night, January – June 2012

Finals June 21st, 2012

Participants must be 21 years or older and have valid photo ID.

Entries

On each Vapor "Hot Country Dance Party" night every month, Country Idol Karaoke contestants can register online at www.wgna.com for a chance to win a spot to sing for that month. Five (5) contestants will be randomly picked from online registration. You can also register at Vapor between 7 and 8:00pm that night. Fifteen (15) Singers will be randomly picked in Vapor for their chance to impress the judges between 8:30-11pm. All registration and check in must be complete by 8:00pm with no exceptions. Song selection must be a song that has been or is currently a Top 40 Billboard Country Hit. *No one who is currently signed with a label will be allowed to compete.

Contest

The top 5 singers of each contest night will be invited back for Country Idol Karaoke Finals on June 21st, 2012. Weekly finalists will receive a t-shirt or similar prize.

The winner of the finals will receive \$5,000.00 cash.

Winners are determined by judge's decision. Judges' decisions are final. Guest Judges will be brought in each month as well as for Country Karaoke Finals on June 21st, 2012.

Additional Rules
