



**Day of 100 Winners Drawing Promotion

Player Extras Club membership and valid photo ID are required to enter contest. Membership is free. Winner must be 18 years or older.

Entries

From 1-10pm, Player Extras Club members playing with their Club card inserted into any video gaming machine at the time of the drawing are eligible win Free Slot Play and participate in our Day of 100 Winners Promotion.

Drawings

The virtual drawings will take place at the PEC every hour from 1-10pm on each drawing date. For each drawing, 10 winners will be selected out of all eligible entries via CMP's Find Players Fast function. The winners will be announced at the Player Extras Club across the gaming floor. Must be present to win. The winners must visit the Club within 5 minutes to claim their prize. If a winner does not report to the Club within 5 minutes to claim their prize it will be forfeited and another winner will not be chosen. If a winner reports to the Player Extras Club within 5 minutes, but does not have valid photo ID, they will be given 30 days from the drawing date to claim their prize with proper photo ID.
