# CONDITIONS

1. "All risks, loss, injury, damage or destruction to person, property and/or horses of the licensee by fire, theft, accident or otherwise, are assumed in full by the licensee, whether caused by the active or passive negligence of the licensor, the condition of the premises or any other reason or cause whatsoever." The undersigned hereby agrees to indemnify and hold harmless Saratoga Casino & Raceway and its officers, employees and agents from and against any injury, loss, damage, liability or cost, including attorneys fees, suffered by Saratoga Casino & Raceway, its officers or employees or by any other person or persons whatsoever by reason of any thing or matter done or failed to be done by the undersigned, his/her agents and employees, or by reason of the condition of or any thing done by any horse or equipment belonging to or in the custody of the undersigned, his/her agents or employees, whether any such damage occurs on the aforesaid premises or elsewhere.
2. The undersigned recognizes that Saratoga Casino & Raceway has the exclusive and inherent right, in the exercise of its own discretion, to revoke and cancel at any time this limited and conditional occupancy and use of all or any of its stall and stable facilities and therefore agrees to and shall remove all or any one or more of his horses, and to vacate such stall spaces within a maximum of 48 hours of any such notice to their removal. In the event of failure of the undersigned to vacate upon notice herein before provided, he does hereby unconditionally waive any and all prevailing applicable statutory procedures to the contrary. In the event of his failure to enter or race any horses or to timely remove any one or all of the horses, he/she does hereby unconditionally further authorize and empower Saratoga Casino & Raceway to remove and place such horses in any private or public stables, farms or the like which may then be available, all at the undersigned's own direct expense and he/she does hereby further hold Saratoga Casino & Raceway and its officers, agents and representatives harmless and free from any and all obligations, liability and expense whatsoever including all disbursements and legal fees in connection with any of the foregoing.
3. Saratoga Casino and Raceway, in the exercise of its own discretion, has the right to reject any entry in a SCR overnight event and return fees paid for any early/late closer sponsored by SCR.
4. Coggins tests for all horses stabled on the grounds must be on file in the Racing Office. Stable rosters and claiming authorizations and registration certificates for horses entered in claiming races must be on file in the Racing Office.
5. In the best interest of racing, Saratoga Casino & Raceway reserves the right to refuse admittance to or eject anyone, considered undesirable.
6. Smoking in horse stalls, feed rooms and under the shed is strictly prohibited.
7. Any stalls assigned as a "horse stall" are not to be locked at any time.
8. No oil or gas-burning lanterns, heating appliances, open pit fires or cooking grills are allowed in the stable area.
9. All electrical appliances used in the stable area must be in safe working condition and, when in use, be located at a safe distance from walls, beds and other furnishings, and shall not be left unattended when in operation.
10. No inflammable material, such as cleaning fluids and solvents shall be used in the stable area.
11. No hay or straw in a loose form may be stored under the sheds or out-side of feed rooms.
12. The alleyways in front of stalls must be kept free of debris and open at all times to give easy access to each stall door in case of fire.
13. All visitors permitted in the stable area are required to sign-in at the stable gate and be escorted by a licensee.
14. All trainers are required to have a certificate for Workers Compensation Insurance on file with the New York State Racing and Wagering Board, (NYSRWB Rule #4101.31).
15. Rules and regulations of the New York State Racing and Wagering Board shall govern the meeting.
16. Horses stabled on the Raceway grounds during a race meet must race at this facility. The exceptions are:
  1. Early and Late Closers (paid events)
  2. Sire Stakes
  3. Horse is of superior ability and too competitive for the local horse colony
  4. Any legitimate reason which is acceptable to the Director of Racing.
17. NYSRWB Rule #4118.4 will be strictly enforced. (re: purse schedule)
18. Any trainer who receives a TCO<sup>2</sup> bloodgas violation at Saratoga Casino & Raceway will lose all privileges of the grounds for an indefinite period not to be less than six months.
19. Saratoga Casino and Raceway reserves the right to draw blood on any horse at any time for the detection of violations to NYSRWB RULE #4120.
20. The undersigned agrees that they will remit to Saratoga Casino & Raceway within ten days of receipt, payment for any repairs to the barns and/or stalls due to neglect or abuse.
21. Further, any vacated stall not found in the condition it was when assigned, the assignee will be assessed a fee of \$25.00 per stall.
22. Violation of any of the above conditions will result in immediate notice to vacate.
23. All horses stabled at SCR must use track required bedding .

## INSTRUCTIONS

1. List name of horse whose papers are at the track. List stable name, coporation, or lessee, is such is the owner and each individual owner of stable corporation, farm, etc. Use one line for each horse.
2. **86.4 Reports on ownership and control of horses** (a) Within 72 hours, or shorter period if so directed, after arrival of any horse at a race track, the person in charge of such horse shall file a statement with the Commission Steward, in form satisfactory to the commission, listing the following information,
  - 1) The owner or owners of each such horse with address, telephone number and commission license number.
  - 2) The trainer and, if any, the assistant trainer, with address, telephone number and commission license number.
  - 3) Each groom or other employee employed for such horse with address and commission license number. If any such employee is thereafter discharged or leaves his employment such fact shall be reported to the Commission Steward within 24 hours.
  - 4) The name and policy number of the workman's compensation carrier if any.
  - 5) The tattoo number of each horse.
  - 6) Such other information as may be required.b) Upon any change in ownership, training or employment regarding such horse during the meeting, the person in charge of the horse shall promptly report that information to the Commission Steward.  
c) The trainer of a horse shall file a statement with the Commission Steward designating an assistant to assume his responsibility when such trainer will not be available for a period exceeding one day.  
d) Copies of all such statements required above shall be filed with the Presiding Judge and Race Secretary.
3. In the space list all your employees here or anywhere who are licensed with the Harness Racing Division of the N.Y.S. Racing and Wagering Board or any other state commission, or the U.S.T.A. in the capacity of trainer or trainer-driver.  
**THIS LIST MUST BE KEPT CURRENT. IT IS YOUR RESPONSIBILITY TO ADD OR DELETE NAMES WHEN APPLICABLE. IT IS RECOMMENDED YOU REVIEW THIS WEEKLY.**  
IF YOU DO NOT TRAIN FOR ANY OWNER LICENSED HERE IN THE STATE, HIS NAME SHALL BE STRUCK. ALSO, IF HORSES NOW BEING TRAINED ARE TURNED OUT AND YOU NO LONGER ARE CONTRACTED OR EMPLOYED ON SUCH HORSES, SUCH OWNERS NAMES SHOULD THEN BE STRUCK LIKEWISE. IF ANY NEW OWNERS CONTRACT OR EMPLOY YOU, THEIR NAMES MUST BE ADDED. OWNERS CAN BE ADDED THROUGH A SALE OF THE HORSE WHICH YOU CONTINUE TO TRAIN OR BY NEW HORSES BEING GIVEN TO YOU TO TRAIN.  
IF YOU TAKE ON OR LET GO ANY EMPLOYEES UNDER NUMBER 3, SUCH SHALL BE LISTED OR STRUCK AT THAT TIME.  
FAILURE TO KEEP THIS LIST UP TO DATE AND IN CURRENT FORM CAN CAUSE FINE, SUSPENSION OR BOTH, AND PREVENT YOUR HORSES FROM BEING RACED.  
THE SIGNER HEREOF REPRESENTS THAT HE AND ALL PERSONS FOR WHOM HE IS ACTING HAVE READ AND ARE FAMILIAR WITH THE RULES AND REGULATIONS OF THE NEW YORK STATE RACING AND WAGERING BOARD, AND THE SPECIAL RULES AND REGULATIONS OF SARATOGA HARNESS RACING, INC., LISTED ABOVE. HE AND THEY UNCONDITIONALLY AND WITHOUT EXCEPTION HEREBY AGREE TO BE BOUND BY AND COMPLY WITH SPECIAL RULES AND REGULATIONS INASMUCH AS THEY ARE INCLUDED AND EXPRESSLY MADE A PART HEREOF. HE AND THEY ALSO AGREE THAT ALL THE ABOVE NAMED HORES ARE AND SHALL BE SUBJECT TO THE AFORESAID RULES AND SPECIAL REGULATIONS AND TO ABIDE BY ALL OF THE ACTS AND DECISIONS OF THE VARIOUS TRACK OFFICERS AND RACING OFFICIALS PRESIDING AT SARATOGA HARNESS. THE ASSOCIATION RESERVES THE RIGHT TO DECLINE STABLE SPACE TO OWNERS AND TRAINERS AND UPON ONE DAYS NOTICE OWNERS AND TRAINERS AGREE TO VACATE.
